## CIRCULAR

This is to notify for all beneficiaries of the Contributory Medical Scheme (CMS) that in terms & conditions of the Agreement executed by AMRI Hospitals Ltd. with Bose Institute, henceforth the following charges/fees charged by any of the units of AMRI Hospitals are to borne by the patient party/beneficiary; i.e the respective beneficiary/beneficiaries of Contributory Medical Scheme of Bose Institute, on actual basis and to be paid directly to the hospital at the time of discharge irrespective of the cashless treatment availed in terms of authorization letter issued to respective beneficiary/beneficiaries by the Institute.

1. The consultation fees with the consultants in Out Patient Department (OPD).

2. Charges of all investigations done outside i.e. not done at AMRI Hospitals (Outsourced

Investigations) at actual.

3. Procedures, viz; Capsule Endoscopy, Dialysis, Bone Marrow Transplant, Kidney Transplant, Sleep Study, APC, Therapeutic Endoscopy, Cardiac CT, Cardiac MRI, MRI of Knee, Shoulder joint, any Single Joint, Fibro scan, Obstetrics & Gynecology, Dental procedures, Blood and any Outsourced investigations both at Outdoor & Indoor and for these services will be charged on actuals as per the individual unit rate offering 15% discount;

4. If an Item is utilized by the patient, which was clinically necessary, and not covered

under CGHS rate, will be borne by the patient party/beneficiary.

5. If there is any requirement of blood to be transfused to the patient during the course of the treatment in the hospital, the same may be provided subject to the availability of blood .The patient has to arrange for the replacement of the same by donors before discharge. A processing charge has to be paid by the patient party/beneficiary in this regard.

6. In case of emergencies where treatment can be rendered on OPD Basis and admission is not required, patient party/beneficiary will settle the charges of treatment

/Consumables/Medicines/ Procedures.

7. In case the eligible Bed is not available, the patient may be accommodated in a higher category, however, the patient will be shifted to his entitled category once the same become available. However, difference of amount for entitled category and higher category will be borne by the patient party/beneficiary and Bose Institute will pay CGHS (Kolkata) applicable rates of entitled category only.

8. For in-patient service, AMRI Hospitals, shall provide a list of Consultants unit wise who

would be honouring the CGHS NABH Rate.

No choice of consultants would be entertained by AMRI Hospitals and in case of separate choice other than the enlisted one, the patient party/beneficiary has to pay their actual fees for consultation, surgery etc.

10. Doctors at AMRI Hospitals may admit a patient in a higher bed category for clinical reasons. Difference of amount for entitled category and higher category will be borne by

the patient party/beneficiary.

11. The treatment requirement in critical care/HDU/isolation room will be the sole discretion of the concerned treating consultant irrespective of the entitled category of bed/ward of the patient.

12. In case the patient party/beneficiary opts for a higher category of bed/ better or costlier implant or prosthesis other than his/her entitlement/upper limit, the difference amount i.e.difference of actual amount and CGHS approved amount will be paid in cash before discharge by the patient party/beneficiary.

13. The patient party/beneficiary will furnish an undertaking with the hospital at the time of

admission to the said extent.
