 - ii) For **JLA** in **Physical Science Programme**, basic knowledge of electrical circuit will be given weightage in the selection process AND/OR screening of application.
 - iii) For **JLA** in **Animal Facility Programme**, experience in animal handling & knowledge of modern animal facility will be given weightage in the selection process AND/OR screening of application.

 - **c.** English
 - d. Mathematical Ability
- 3. Interview.

- 2. <u>Only</u> applications received online will be processed. Candidate should send the hard copy of the online application (with applicant's code which will be generated only after submitting the application) along with attested copies of all certificates and testimonials so as to reach by **16th May**, **2013** till **15.00** hrs.(IST). Applicants Govt./Semi Govt./Autonomous Organization should send the hard copy through proper channel.
- 3. The System will <u>not</u> accept any application after **15.00** hrs. (IST) on **06.5.2013**.
- 4. Copies of Certificates/ Testimonials need <u>not</u> be attached at this stage with the online application.
- 5. Eligibility criteria including the upper age limit will be reckoned on the last date of submission of application, i.e., on **06.5.2013**.
- 6. The short-listed candidates will be intimated the date of written test & interview at their respective email IDs. The list will also be available in this website. <u>No</u> individual letter to the candidates will be sent.
- 7. Before applying, the applicants should ensure that they posses at least the essential qualifications laid down for the post and other conditions stipulated in the advertisement. If a candidate is found not eligible, his candidature will be cancelled at any stage of the recruitment.
