Applications are invited from Indian Citizens for Two posts of Animal House & Laboratory Technician to work in the "Centre for Translational Animal Research" at J. C. Bose Biotechnology Innovation Centre, Madhyamgram Experimental Farm of Bose Institute, Kolkata. The post is purely temporary for initially one year period on contractual basis.

- 1. Name of the post: Animal House & Laboratory Technician: Two (02) posts
- 2. **Essential Qualification**: 1st Class Bachelor's in Veterinary Science/ 1st Class Masters in Zoology/Physiology/Animal Biotechnology.
- 3. **Desirable Qualification**: Experience in handling and maintenance of Laboratory Animals in a Modern Animal House. Training/experience on Laboratory techniques.
- 4. **Remuneration (Consolidated):** Rs. 15,000/- per month.

Age: 35 years for general candidate (SC/ST/OBC candidate will get relaxation as per Government of India Rules; age relaxation may be given to qualified candidate).

- 5. The interview of short-listed candidates will be held on **16.09.2014** from 11.00 am at Bose Institute, Centenary Building, P-1/12, C.I.T. Scheme VII M, Kankurgachi (near Manicktala ESI Hospital), Kolkata 700 054.
- 6. Before applying, the applicant should ensure that they posses at least the essential qualifications and other conditions stipulated in the advertisement. If a candidate is not found eligible, his/her candidature will be cancelled at any stage of recruitment. It may also be noted that even if a candidate qualifies in the test/interview and subsequently it is found that he/she does not fulfil the eligibility criteria, his/her candidature will be cancelled.
- 7. The prescribed essential qualifications are the minimum and mere possession of the same does not entitle a candidate to be called for interview. In the event of number of applications being at large the Institute will resort to short listing criteria to restrict the number of candidates to be called for interview to a reasonable limit by written test and/or any other criteria.
