Candidate should send the hard copy of the online application (with applicant's code which will be generated only after submitting the application) along with attested copies of all certificates and testimonials so as to reach by **05.08. 2016** till **15.00** hrs.(IST).
- 3. The System will not accept any application after 15.00 hrs. (IST) on 01.08.2016.
- 4. Copies of Certificates/ Testimonials need not be attached at this stage with the online application. However, self attested copies of the same should be attached while submission of hard copy of application.

- 5. Eligibility criteria including the upper age limit will be reckoned on the last date of submission of application, i.e., on **01.08.2016**.
- 6. The short-listed candidates will be intimated the date of interview at their respective email IDs. The list will also be available in this website.
- 7. Before applying, the applicants should ensure that they posses at least the essential qualifications laid down for the post and other conditions stipulated in the advertisement. If a candidate is found not eligible, his candidature will be cancelled at any stage of the recruitment.
