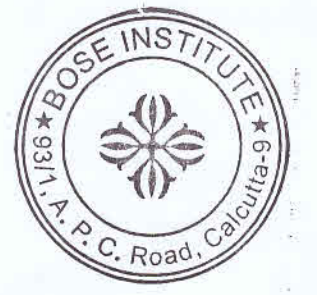

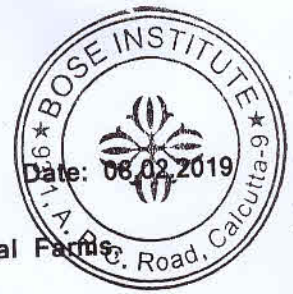

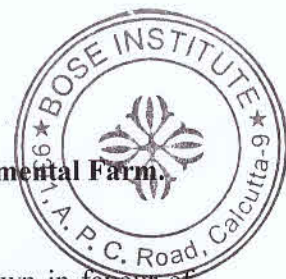

In connection with Lease of Trees and Ponds at our Shyamnagar Experimental Farm.

1. Earnest money should be deposited in the form of demand draft, drawn in favour of Bose Institute, Kolkata along with tender documents.

THE TENDER WILL NOT BE CONSIDERED IF THE EARNEST MONEY IN THE ABOVE MANNER IS NOT SENT ALONG WITH THE TENDER.

Earnest money should not on any account bear any interest. It will be refunded to the unsuccessful bidders only after finalization of the contract.

2. Incomplete tenders will be liable to cancellation.
3. Bose Institute reserves the right to reject any or all tenders without assigning any reasons thereof.
4. Bose Institute will not be liable for any loss/spoilage of any produce during the lease period.
5. Successful bidders shall have to deposit the full bid money through Demand Draft in favour of Bose Institute, Kolkata within 07 (Seven) days from the date of receiving the lease permission from Bose Institute.
6. Tenders received beyond the schedule date and time will not be entertained in any case.
7. Tenderers has to submit copy of Voter ID, Aadhar card and Pan card.
8. The Institute reserves the right to split the tender.
9. Trees are to be dressed and ponds to be cleaned up by the successful bidder at their own cost at initial stage, if found to be essential.
10. Lease holder/s will have to make their own arrangements for maintenance of trees/fields & ponds during the lease period and for carrying away the produce in appropriate time with prior approval of the Scientist-in-Charge of the concerned Farm. Entire responsibility for keeping the garden area clean will lies upon the successful bidder.
11. In case of posting of any person/s on behalf or the lease holder/s for maintenance of Tree(s)/ fields & ponds, bio-data as well as passport size photograph including photo identification of the person/s are to be submitted for permission.
12. Lease holder/s will be liable for any sort of damages to our Farms, if occurred, caused directly from arrangements made by him for maintenance of Tree(s)/field and ponds. In that case, it will be compensated against the Earnest Money and/or produce obtained from the leased Trees, otherwise the Earnest Money retained by the institute will be refunded after the lease period is over.
13. The original copy of the tender schedule duly filled in along with attached terms and conditions is to be returned intact. The envelop/offer may be submitted in the office of the Registrar, Bose Institute clearly mentioning our tender No. & date.



14. All communications must be addressed to the Officer, by title of Concerned Officer of Bose Institute and not by any name.
15. Trees available for lease may be seen on any working day during Office hours before submission of offer.
16. The Tender shall be opened by a committee constituted by the Bose Institute Authority. You are at liberty to be present or authorize your representative to be present at the opening of the tender at the time and date specified in the schedule.
17. In the event of any question, dispute or differences arising under this contract, the same shall be referred to the sole arbitration of the person appointed by the Director, Bose Institute. The awards of the arbitrator shall be final and binding on the parties.
18. **Removal of Garbage:** Dry leaf and small pieces of tress branches from the field site from time to time as per direction of Scientist-In-Charge, S.E.F.
19. **Indemnifying against damages:** Contractor shall during the course of execution, be responsible for all damages to property and for any injury or loss caused to the work or workmen to persons or things. The contractor shall make good all such damages, the course of execution at their own cost/ risk.
20. **Work during holidays etc.:** Prior approval from the Competent Authority has to be obtained for persons to be engaged during holidays and/or beyond office hours, in listed form, mentioning their names and addresses.
